PART I: OVERVIEW AND TRENDS

The 50th Session of the Commission for Social Development took place at the United Nations Headquarters in New York from 1 to 10 February 2012. The priority theme was "Poverty Eradication".

This year, an unprecedented high number of **908 persons** pre-registered, representing 270 non-governmental organizations. This is a record in the history of the Commission. An increase in the number of NGOs participating has been achieved, from 97 NGOs in 2011 to 118 NGOs, with 324 representatives compared to 290 representatives last year. It should be noted that some NGO representatives holding annual badges dot not pre-register or register to attend sessions of the Commission. An increase in the number of NGO written statements has been achieved from 24 to 28 statements. The number of side events has been increased from 23 to 29. The number of oral statements has also been increased from 8 to 18.

The increase in the number of civil society organizations can be attributed to the inspiration, support and confidence that the Civil Society and Outreach Unit benefited from the Director of the Division and the use of innovative communication and outreach strategy by the CSOU team. It should be noted that the Civil Society and Outreach Unit has been working in an active, productive and collaborative manner with external partners such as the NGO Committee for Social Development.

The outreach campaign has also been innovative in the kind of communication material produced, which has increased the visibility of the interaction between civil society entities and DSPD, including the first online report on Civil Society Participation in the 2011 Commission for Social Development. An eBook has been available on the website and shared with our NGO partners.

Asia and North America continue to submit the highest number of representatives, reaching 240 for 2012; the participation of European NGOs is also growing from 31, in 2011, to 46 representatives, in 2012; African NGOs account for 12 participants, and Latin America and Caribbean had 20 representatives.

The NGO Committee for Social Development acknowledged with appreciation the work performed by the Division for Social Policy and Development (DSPD) though a letter. It requested the Secretariat to continue this fruitful cooperation, taking into account preparations for the next session of the Commission focusing on the theme of "Promoting empowerment of people in achieving poverty eradication, social integration and full employment and decent work for all". The Committee also stressed the need to expand the interaction with DSPD through other initiatives, including activities that enhance the outreach of the DSPD.

a. Civil Society Participation

- CSOU co-sponsored, coordinated and facilitated the organization of the Civil Society Forum (attended by more than 500 NGO representatives) through joint actions with the Conference Service, Security and Safety Service, Special Events Service. As usually, the Forum took place one day before the Commission. It is an unique gathering offered by DSPD in support of the work of civil society organisations in conjunction with sessions of the Commission. This year, the theme of the forum was "The Social Protection Floor Initiative (SPFI) Bridging the Gap to Poverty Eradication." This year, the NGO Committee prepared the "Million Signature Campaign Delivery" which was delivered to H.E. Mr. Miloš Koterec, Sixty-eighth President of the Economic and Social Council, Permanent Representative, Permanent Mission of Slovakia to the UN.
- CSOU pre-registered online 908 representatives from 270 NGOs and facilitated the participation of 324 representatives from 118 NGOs
- CSOU conducted the actual registration of 324 representatives from 118 NGOs
- CSOU facilitated and participated at the morning NGO briefings during the session
- CSOU facilitated 18 oral statements made by NGOs during the session
- CSOU facilitated the organization of 29 side events during the session
